# 2. COLLECTION, USE, AND DISCLOSURE OF PERSONAL INFORMATION

We or any insurer, to whom we submit your application may collect, use and disclose personal information from you and about you for the following purposes:

- a) to understand the clients needs

- to asses the clients ongoing needs for insurance
- d) to analyze the clients needs for and/or offer other products and services
- e) to facilitate any claim made by or on behalf of the client
- f) consent may be assigned by Reider Insurance Services to any other assignee

#### 3. DISCLOSURE

The broker may disclose client information to the following third parties:

- a) insurance companies
- b) other brokers
- c) credit organizations
- d) professionals working on behalf of the broker or insurer (ie. adjusters and lawyers)
- e) financial institutions
- f) medical professional
- any party as required by law or regulatory requirements

### 4. THIRD PARTY INFORMATION

The broker may obtain client information from the following third parties:

- a) insurance companies
- b) other brokers
- c) credit organizations
- motor vehicle and driver licensing authorities
- e) financial institutions
- f) professionals working on behalf of the client (ie. lawyers)

#### 5. WITHDRAWL OF CONSENT

The client may generally withdraw consent at any time. If the client refuses or withdraws consent, Reider Insurance may not be able to provide or continue to provide you with some products, services or information.

#### 6. ACCURACY

All information, which the client gives us at any time, will be accurate and complete and the client will not withhold any material (ie. pertinent or relevant) information. The client must inform Reider Insurance immediately of any new or changed information.
